The Lafia Learning Center has twenty internet-connected computer workstations open to residents and the community and sees 50 unique students each month. Students use the center to learn Microsoft Office skills, sharpen reading skills, perform job searches, access online learning resources, and stay connected with others through email. For those who are hungry, we provide something to eat; for those who are thirsty, something to drink; for those who need a place to stay, we provide a home; for those who need clothing, a coat to keep them warm; and for those who are sick, a free walk-in clinic is provided. In addition to the CTM café, clothing distribution and educational opportunities, residents are given the chance to create a Personal Success Plan. This is a mentored, goal-oriented program that enables individuals to grow spiritually, academically, and vocationally. This is facilitated through mentoring, classroom work, life
